# REQUEST FOR PROPOSAL AUDIT SERVICES

beginning with 2026/27 fiscal year audit, for term of 5 years





### 1. OUR ORGANIZATION

Founded in 1996, the Comox Valley Community Foundation (CVCF) is a public charitable foundation, registered as an extra-provincial society pursuant to the Canada Not-for-profit Corporations Act – 2014-04-08 (# 325469-1). CVCF works with local families, businesses and organizations to create permanent endowment funds that enrich life in the Comox Valley through the distribution of grants to local non-profit organizations and scholarships to students pursuing post-secondary education.

CVCF is governed by a volunteer Board of Directors, currently comprised of up to 12 local individuals, which normally meet up to 8 times per year.

### Mission

Connecting our community to enrich life for all.

### **Value Statements**

- **Trust** Integrity and transparency are at the core of everything we do.
- **Compassion** Compassion and belief in our community is the reason for our work.
- Inclusivity Our door is always open to everyone.

- Collaboration We listen and learn with our community and build highly collaborative and impact focused partnerships to activate resources to respond to emerging issues and opportunities.

### 2. FINANCIAL POSITION

CVCF's total net assets are approximately \$20 million invested with Vancouver Foundation and in short-term investments. Income received from these investments is distributed as scholarships and to local charities by way of grants. Distributions for the fiscal year ended March 31, 2025 were \$1.3 million and will be over \$1.3 million again for the fiscal year ending March 31, 2026.

The operating budget for the year ending March 31, 2026 is approximately \$500,000. Operations are funded by a 1.5% administrative fee on fund balances, proceeds from annual fundraising efforts, miscellaneous grants and a small endowment fund that supports operations. There are currently four full-time staff members.
